MINUTES

A meeting of the California Authority of Racing Fairs (CARF) Board of Directors was held at 1:00 P.M., Tuesday, May 3, 2016. The meeting was hosted at the CARF Board Room, 1776 Tribute Road, Sacramento, California.

CARF Board Directors attending: John Alkire, Richard Conway, Jerome Hoban, Dan Jacobs and Rick Pickering. Joining by conference call: Kelly Violini.

Staff and Guests attending: Christopher Korby, Larry Swartzlander, Tom Doutrich, Heather Haviland, Juliana Gomes, Raechelle Gibbons, Ann Grottveit, Jeanne Wasserman, John Quiroz, Tom Martinez and Allen Aldrich.

Agenda Item 10 - Closed Session (Personnel: Executive Director). Mr. Alkire stated that the CARF Board would break into closed session prior to the public portion of the meeting.

Report on Closed Session. Mr. Alkire reported that no action was taken in closed session, however direction was given from the Board to the Chairman and legal counsel.

Agenda Item 1 – Date, Time and Location of Next Meeting: June 7, 2016. The next CARF Board of Directors meeting is scheduled for June 7, 2016 in Sacramento.

Agenda Item 2 – Public Comment. None.

Agenda Item 3 – Approval of Minutes. Mr. Conway moved to approve the meeting minutes as presented. Mr. Hoban seconded, unanimously approved.

Agenda Item 4 – Report, Discussion and Action, if any, on 2016 Legislative Program. Mr. Korby reported that the CARF bills are moving through the legislative process without opposition.

Mr. Korby reported that Assemblymember Gray's Internet poker bill, AB 2863, was heard in policy committee last week and passed unanimously through the Assembly Governmental Organizational (G.O.) Committee on a 19-0 vote despite not having full support of the tribal community. The bill has now moved to the Appropriations Committee and will be heard as part of the suspense calendar. Just as things were looking hopeful for Internet poker,

U.S. Senator Dianne Feinstein issued a letter in opposition of the bill, which represents an example of the political challenges facing Internet poker.

Agenda Item 5 - Report on Reimbursement of Tote Installation Construction Costs.

Mr. Korby reported that an arrangement was worked out with NCOTWInc. to develop a partial installation cost reimbursement formula for Northern California satellites. A check will be sent to CARF and then disbursed back to satellites based on the number of windows at each location. CARF is going to match that allocation with facility improvement funds held at the agency. The total contribution from NCOTWInc. is \$30,000 which includes Golden Gate Fields and fair satellites. The portion allocated to satellites will be approximately \$22,000 and will be matched by CARF.

Agenda Item 6 – Report on CARF Conference and Annual Meeting. Mr. Korby stated that many of those in attendance at today's meeting were also able to attend the CARF Membership Conference April 11-12, 2016 in San Mateo. Mr. Korby stated that all reports back from the conference were positive.

Ms. Haviland reported that there were 39 attendees and thanked everyone who participated, especially the San Mateo Event Center staff for hosting the event. Mr. Hoban congratulated staff for a conducting a successful conference and expressed the hope that attendance would grow in the future and staff would continue to develop topics to educate and assist satellites. Mr. Alkire suggested another conference be conducted in 2017 in Southern California and thanked staff for their efforts.

Agenda Item 7 - Resolution of Appreciation to San Joaquin County Fair. Mr. Korby suggested that the CARF Board formally thank the San Joaquin County Fair Board for their collaboration and efforts to transfer race dates to the Alameda County Fair. Mr. Korby stated that he drafted a letter and asked the Board to take formal action and sign the document as it is circulated. Mr. Hoban thanked Mr. Korby and stated that his Board will take similar action.

Mr. Hoban moved to present a resolution of appreciation to the San Joaquin County Fair. Mr. Conway seconded, unanimously approved.

Agenda Item 8 – Financials. Ms. Gibbons reported that the 2015 CARF audit is scheduled to begin May 23, 2016.

Agenda Item 9 – Executive Director's Report. Mr. Korby reported that Balmoral Park in Illinois has declared bankruptcy and materials pertaining to that action have been handed off to legal counsel to review on behalf of all CARF-member fairs. If individual locations received any materials pertaining to the proceedings they should file them in a safe location, but no action is required unless notified by CARF staff.

This will serve to memorialize agreement among the undersigned with respect to funding of the California Horse Racing Board, ("CHRB"). The undersigned hereby agree among themselves that each will make the following payments:

1. Section 19616.51 of the Business and Professions Code was amended by ABX4 12, and now stipulates:

(a) Notwithstanding any other law, and in lieu of any license fee payable to the state prescribed for or referred to in Section 19491, 19491.5, 19596.3, 19601, 19601.2, 19602, 19603, 19604, 19605.25, 19605.35, 19605.45, 19605.6, 19605.7, 19605.71, 19606.5, 19606.6, 19610.8, 19611, 19612, 19614, 19616, 19616.1, 19616.2, or 19641, any association or fair that conducts a racing meeting shall only pay its proportional amount, as determined by the formula devised pursuant to paragraph (1), as a license fee to the state, to be deposited into the Horse Racing Fund, which is hereby established, to fund the board and the equine drug testing program as follows:

(1) All racing associations and fairs including all breeds of racing shall participate in the funding of the board in accordance with a formula devised by the board in consultation with the industry.

For the 2016-2017 fiscal year, the CHRB's operating budget has been determined by the enactment of Section 19616.51 to be \$13,469,000 and such amount shall be subject to change in future fiscal years. The undersigned are responsible for the funding of the CHRB's annual operating budget by depositing the necessary funds in the California Horse Racing Fund. The amount to be so deposited by each of the undersigned shall be a percentage of the License Fee that would have otherwise been payable by the undersigned in the absence of the enactment of SB 16XX and for each fiscal year a determination shall be made as to the percentage necessary to generate the amount for the funding of the CHRB operating Budget. For the 2015-2016 fiscal year such percentage shall be 61%. Thus, during the 2016-2017 fiscal year, the undersigned shall each pay 61% of the License Fee that would have otherwise been payable by each if SB 16 XX had not been enacted.

The undersigned shall remit the respective amounts they owe no later than Friday for amounts generated during the prior week (Monday through Sunday) for wagers placed at brick and mortar sites within California. For amounts generated by wagering outside the State of California on races conducted in California ("export wagering") including wagers placed through ADW providers, the undersigned will remit the respective amounts they owe within ten business days of the receipt of host fees generated from export wagering.

It is recognized that a determination of true-up amounts will be necessary at the end of each fiscal year. Excesses and shortfalls in funding shall be determined after the end of the fiscal year. Should a shortfall occur, the payments required by the undersigned shall be determined by calculating the percentage of each entity's contribution to the total funding generated in the current fiscal year and then applying such percentage to the shortfall. The CHRB will notify the undersigned of their shortfall amounts, and the undersigned will remit payments within ten business days of such notification. Should an excess occur, an amount equaling the percentage of each association's contribution to the total funding generated in the current fiscal year shall be applied to the total excess generated in the current fiscal year, and that amount shall be returned to each association in the following fiscal year.


2. The CHRB is a third party beneficiary of the payments to be made by the undersigned pursuant to paragraph 1 hereof, therefore, the CHRB has a right to bring an action against any of the undersigned who fail to make the prescribed payments in paragraph 1 hereof. Payments to be made by the undersigned are the sole responsibility of that entity; therefore, there is no joint and several liability among the undersigned for the failure of anyone to make the prescribed payments.

3. This Agreement may be signed in counterparts.

4. California Horse Racing Industry Organizations which have agreed to participate in the funding described above include: California Authority of Racing Fairs, Del Mar Thoroughbred Club, Los Angeles County Fair Association, Los Alamitos Racing Association, Los Alamitos Quarter Horse Racing Association, Los Angeles Turf Club, Pacific Racing Association, Sonoma County Fair, Watchandwager.com LLC, California Harness Horsemen's Association, California Thoroughbred Breeders Association, Pacific Coast Quarter Horse Racing Association, and Thoroughbred Owners of California.

All;

As a follow-up to our meetings and Nick's recent email proposal, please consider the following:

Goal: to add \$30 million (or more) to purses and commissions by adding more minisatellites while simultaneously providing a mechanism to modernize existing satellites for the benefit of current customers.

In order to achieve that goal the industry needs to 1) provide an incentive for existing satellites to reduce their 20 mile exclusivity circles and 2) as important: establish a plan for business development that will include sales people, marketing materials, and legal expertise to deal with local cities.

Background: Minisatellites were authorized in 2007. Regulations were completed in 2009. In the ensuing 6 years, only 10 minis have been opened statewide. However, in 2015 the handle from just 8 minisatellites (excluding Striders) in southern California equaled:

- 6% of total handle in California, including ADW;
- 9% of handle at all brick and mortar locations in CA, including tracks;
- 13% of handle at all CA satellites;
- 19% of handle at all satellites in the south;
- 48% of handle at all satellites in the north.

Also:

- The 8 minisatellites contributed nearly \$8.2 million net to purses and commissions in 2015.
- Other than ADW, only minisatellites offer an opportunity for growth.

If the revenue produced at the 8 minisatellites in southern California was replicated by just 50% at the maximum allowable 45 locations throughout the state, the net increase to purses and commissions would be more than \$30 million annually.

Everyone agrees that this unique opportunity for growth should be aggressively pursued. Yet, to date, one or two people have been knocking on doors on an anecdotal, hit-and-miss basis. And there's plenty of other NCOTWinc and SCOTWinc business to keep the current staff occupied.

Given the hit to purses and commissions due to Workers Comp increases, it certainly makes sense to move cautiously, i.e., to do a pilot project. However:

- The proposal to award an existing satellite a ½% increase in commissions from its handle to be used solely for capex might not be a sufficient incentive, considering that business at the satellite would certainly be impacted to some degree. The existing satellite would need to compete with a new minisatellite, which will probably be part of a nice restaurant, that doesn't charge admission, offers a full menu vs. concession food and at a better price. Some might argue "survival of the fittest": if the satellite can't compete let it go out of business. But a satellite that refuses to reduce its circle will likely continue to exist for years. Its current customers are important to the game and we don't want to lose them. And, our goal is to reduce the circles while fixing-up the existing locations.
- Under the ½% capex proposal, the San Jose satellite would receive \$116,000 for capex based on its handle in 2015. But that would be offset by some loss of business. If it lost 10% of handle its commissions would be reduced by \$46,650. In addition, it would stand to lose 10% of its admissions and F&B revenues. If those revenues amounted to a net \$5 for every \$300 wagered, the loss would be \$38,900. As a result, the satellite would lose \$85,000 in net operating revenues in exchange for \$116,000 in capex improvements. Not a great incentive for reducing its circle.

Instead, consider the following proposal for existing satellites:

- Target 2-4 significant satellites. Likely candidates to choose from in the north are San Jose, Pleasanton, Vallejo, Santa Rosa and maybe Ventura in the south.
- Offer a participating satellite a one-time, upfront payment of perhaps \$25,000 for capex.
- The rest of the compensation will come from NEW money over 10 years. For the first five years that the mini is open, distribute 1.5% of its handle to the existing satellite that reduced its circle to make it happen. Half to capex as discussed, the other half to its bottom line.
- For the second 5 years reduce the award to 1%.

To be clear: these distributions would not come from the satellite's handle but rather from handle at the new minisatellite location. Using the San Jose example, rather than receiving ½% increase in commissions from its own handle for capex at \$116,000, it would receive 1.5% from the new minisatellite's handle. Based on business of \$10 million at the mini, SJ would receive \$75,000 for capex and \$75,000 for its bottom line. So the old satellite would be paid with new money, and if the handle from the mini is weak, so is the payment to the satellite. That way the industry doesn't get stuck with a bad deal. Also, the satellite would have an incentive for multiple minis within its reduced circle. And it doesn't cost the industry anything other than the upfront payment.

In addition, to further business development, consider this proposal:

- From current and new satellites earmark a distribution of ½% for business development. In 2015, this would have generated \$400,000 for salespersons, marketing materials and advertising and, maybe most important, legal expertise to deal with the cities.
- For NEW minisatellites, raise the city's share from .0033 to .0066. That would give the prospective city a reasonable incentive to facilitate these things. This may require a change in the statute.

Except for the small upfront payment and the business development part, this proposal is based on spending new money and it gives a satellite a meaningful incentive to reduce its circle.

As Nick suggested, let's meet again soon to discuss this and other proposals. We'll check everybody's availability over the next couple of weeks.
