CALIFORNIA AUTHORITY OF RACING FAIRS Board of Directors Tuesday, November 6, 2018

MINUTES

A concurrent meeting of the California Authority of Racing Fairs (CARF) Board of Directors and Live Racing Committee was held at 11:00 A.M., Tuesday, November 6, 2018. The meeting was hosted at the CFSA Conference Room, 1776 Tribute Road, Sacramento, California.

CARF Board Directors attending: John Alkire, Jerome Hoban and Dana Stoehr. Joining by conference call: Richard Conway and Kelly Violini.

CARF Live Racing Committee attending: John Alkire and Jerome Hoban. Joining by conference call: Richard Conway.

Staff and Guests attending: Larry Swartzlander, Tom Doutrich, Heather Haviland, Juliana Gomes, Ann Grottveit, John Quiroz, Abe Andrade and Armando Carlos. Joining by conference call: Cody Boyles, Allen Aldrich and Caroline Titus.

Agenda Item 1 – Date, Time and Location of Next Meeting. The next CARF Board of Directors meeting is scheduled for December 4, 2018 in Sacramento.

Agenda Item 2 – Public Comment. None.

Agenda Item 3 – Approval of Minutes. {ACTION} Ms. Stoehr moved to approve the June 20, June 29 and July 5, 2018 CARF Board of Directors & Live Racing Committee concurrent meeting minutes as presented. Mr. Hoban seconded, unanimously approved.

Agenda Item 4 – Report, Discussion and Action, if any, on the 2018 Legislative Program. Mr. Boyles stated that he has been assisting Mr. Brown in writing the "Northern California Racing Sustainability Act," building off of ideas discussed at the CARF strategic planning session held Aug. 12-13 in Sacramento. Staff is reviewing existing code to look for items that are outdated and/or in need of revision. Mr. Boyles reported that a meeting is being set for November with Assemblymember Adam Gray to discuss sports wagering and fairs.

Mr. Swartzlander asked Mr. Quiroz if there is any action CARF can take to move forward distribution of the "gray area" fair-racing license fees being held at CDFA. Mr. Quiroz stated that he will be following up with legislative staff to see what options are available and next steps. Mr. Hoban asked if these were the funds that had been under discussion in the March Board meeting. The answer was affirmative.

Agenda Item 5 – Report, Discussion and Action, if any, on 2018 Racing Operations. Mr. Swartzlander reported that the Big Fresno Fair meet closed out the 2018 Fair Racing Circuit in mid-October. Mr. Swartzlander stated that early projections show the consolidated purse fund as underpaid for 2018.

Mr. Swartzlander reported that Monarch Content Management sent a letter declaring their intent to decline renewal of the simulcast representation agreement with CARF that expires December 25, 2018. CARF staff is taking steps to secure simulcast agreements in-house, including possible consultation for staff training.

Mr. Swartzlander reported that the stabling agreement with Golden Gate Fields has been signed and stall rent will be collected from trainers not participating on the fair circuit.

Mr. Swartzlander stated that Chris Griffin is confident he is close to securing a significant sponsor for the 2019 racing circuit.

Agenda Item 6 – Report, Discussion and Action, if any, on CARF Office Move February 1, 2019. Ms. Haviland reported that staff is ontrack to complete the office move from Suite 205 to an office space within CFSA's suite in early February. Mr. Hoban requested that surplus office furniture be made available for use in the fair racing offices as needed.

Agenda Item 7 – Report, Discussion and Action, if any, on NCOTWINC. Mr. Swartzlander reported that The Stronach Group (TSG) is attempting to revamp the state's northern simulcast system into a network of betting cafes that will funnel bets through TSG's account wagering service XpressBet. Pacific Racing Association (PRA) took the first step by submitting a CHRB application that stated they will be conducting simulcast wagering with southern California sites only. CHRB declined to vote on the license application during the October meeting and TSG is seeking a simulcast agreement with Northern California satellites.

Mr. Swartzlander stated that the CARF Board had previously given staff direction not to sign another simulcast agreement until the NCOTWINC pension liability issue is solved. Mr. Swartzlander recommended getting Kahn, Soares & Conway, LLP involved to determine legal responsibilities regarding NCOTWINC pension.

Agenda Item 8 – Report, Discussion and Action, if any, on CARF Financials and Accounts. Mr. Alkire reported that financials are included in the meeting packet and called for questions.

Ms. Haviland reported that a CARF racing trust account has Chris Korby as the designated signer and Board action is required to change signers. **{ACTION}** Mr. Conway moved to change

designated signers on the CARF racing trust account to Mr. Alkire, Mr. Swartzlander and Ms. Haviland. Mr. Hoban seconded, unanimously approved.

Agenda Item 9 – Executive Director's Report. Mr. Swartzlander reported that a CARF Finance Committee will be held Thursday, Nov. 29, 2018 in Sacramento.

Agenda Item 8 – Closed Session: Conference with Legal Counsel – Anticipated Litigation. Ms. Grottviet reported that during closed session there was a motion made by Mr. Hoban and seconded by Ms. Stoehr to give direction to executive staff to negotiate a Northern California satellite agreement with PRA, accepting terms no less than what is offered in the current agreement, for the betterment of Northern California horse racing. The motion passed unanimously.

MINUTES

A concurrent meeting of the California Authority of Racing Fairs (CARF) Board of Directors and Live Racing Committee was held at 11:00 A.M., Tuesday, December 11, 2018. The meeting was hosted at the CARF Conference Room, 1776 Tribute Road, Sacramento, California.

CARF Board Directors attending: Jerome Hoban and Rick Pickering. Joining by conference call: John Alkire, Richard Conway, Geoff Hinds and Kelly Violini.

CARF Live Racing Committee attending: Jerome Hoban and Rick Pickering. Joining by conference call: John Alkire and Richard Conway.

Staff and Guests attending: Larry Swartzlander, Tom Doutrich, Heather Haviland, Juliana Gomes, Raechelle Gibbons and Tom Martinez. Joining by conference call: Louie Brown, Cody Boyles, Lauri King, Alan Conrad and Caroline Titus.

Agenda Item 1 – Date, Time and Location of Next Meeting. The next CARF Board of Directors meeting is scheduled for February 5, 2019 in Sacramento.

Agenda Item 2 – Closed Session: Public Employee Performance Evaluation – Executive Director and Staff. Mr. Brown reported that no action was taken in closed session.

Agenda Item 3 – Public Comment. None.

Agenda Item 4 – Approval of Minutes. {ACTION} Mr. Conway moved to approve the July 17, August 7 and October 11, 2018 CARF Board of Directors & Live Racing Committee concurrent meeting minutes as presented. Mr. Hoban seconded, unanimously approved.

Agenda Item 5 – Report, Discussion and Action, if any, on the 2019 Legislative Program. Mr. Brown reported that the legislature was sworn in during the first week of December thereby convening the 2019-20 Regular Session. Committees are still being assigned, but it is probable that Assemblymember Adam Gray will continue to serve as Chair of the Governmental Organization (G.O.) Committee and will continue to be active in sports wagering.

Mr. Brown reported that initial language has been drafted and circulated to Board members for the CARF "Northern California Racing Sustainability Act." Staff will send multiple versions of

that language to legislative counsel for consideration regarding which aspects might be introduced in mid-February.

Mr. Brown reported that no racing or gaming bills have been introduced at this time, but staff is scheduling a meeting with Assemblymember Gray after the holiday break. Mr. Brown stated that he has also has had conversations with Secretary Ross regarding the "gray area" license fees from racing and she is making it a priority to resolve those funds for the benefit of racetrack safety and maintenance by the end of the year.

Agenda Item 6 – Report, Discussion and Action, if any, on Sports Wagering. Mr. Swartzlander reported that he attended the University of Arizona Global Symposium on Racing December 3-5 in Tucson. The legalization of sports wagering was a hot topic and it was mentioned that the California satellite network has the ideal infrastructure to quickly implement sports wagering. The largest detractors to racing's involvement in other states, and in California specifically, is expected to be from tribal gaming establishments.

Agenda Item 7 – Report, Discussion and Action, if any, on 2019 Racing Operations. Mr. Swartlander reported that final purse numbers are not available, but that fairs are still expected to be underpaid for 2018.

Mr. Swartzlander reported that per November Board direction, he signed a satellite agreement with The Stronach Group (TSG)/Pacific Racing Association (PRA) for the upcoming Golden Gate Fields (GGF) meet. The agreement mirrors services/expenses of the prior agreements.

Mr. Swartzlander stated that staff is scheduling separate meetings with TOC and representatives of TSG to discuss the existing satellite network and expansion of mini-satellites.

Agenda Item 8 – Report, Discussion and Action, if any, on Agency Budget. Mr. Swartzlander reported that the 2019 CARF Agency Budget is included in the meeting packet. The budget is similar in structure to prior budgets and has been reviewed by the CARF Finance Committee. Areas that are overspent include race track maintenance and legal fees, with other categories on-target or underspent.

Ms. Gibbons provided a detailed presentation of the Agency Income Statement, Southern Satellite Program Sales, Live Racing Income Statement and Statement of Net Position (formerly presented as the Balance Sheet).

Mr. Pickering clarified that though live racing expenses are run through the CARF books and CARF pays significant live racing expenses, those expenses are reimbursed dollar for dollar by the live racing fairs based on the number of race days. Mr. Swartzlander added that the live racing expenses that each fair decides to run through CARF can vary year by year and can make it appear that "CARF expenses" have increased though the bottom line to the fair is the same.

(ACTION) Mr. Hoban moved to approve the 2019 budget as presented with one modification based on Finance Committee and closed session discussions: to adjust the salary category on the Live Racing Income Statement to \$312,666. Mr. Pickering seconded with the clarification that the budget is being reduced \$32,500. Unanimously approved.

(ACTION) Mr. Pickering, on behalf of the Finance Committee, moved to approve a general employee bonus pool tied to 2018 performance evaluations to be determined at the discretion of the Executive Director not to exceed \$12,500. Mr. Conway seconded, unanimously approved.

Mr. Pickering reported that a performance evaluation of the Executive Director is currently being conducted and is separate from the general employee bonus pool.

Agenda Item 9 – Report, Discussion and Action, if any, on Humboldt County Fair Purses and Commissions Proposal. Mr. Swartzlander reported that when the California Horse Racing Board (CHRB) approved the 2019 Northern California racing calendar, Humboldt County Fair was granted concurrent race dates with Golden Gate Fields (GGF). Mr. Swartzlander reported that he recommends discussing the financial details of the 2019 Stabling Agreement and options for recouping commissions lost to Ferndale with the elimination of their host status. Mr. Swartzlander stated his proposals are included in the meeting packet as handouts titled "2019 HCF Commissions Proposal" and "Explanation of HCF Purses and Commissions Proposal." The group discussed aspects of the proposal and which figures were actual versus future estimates.

{ACTION} Mr. Hoban moved to approve the proposal in concept, as a game plan to help the Humboldt County Fair recoup lost host-status commissions, but to table the exact formula and dollar figures based on results of the 2019 racing season. Ms. Violini seconded, unanimously approved.

Agenda Item 10 – Executive Director's Report.

- Chris Griffin has an important call this evening with a significant sponsor.
- TOC has verbally agreed to secure Ann Grottviet as legal counsel regarding the NCOTWINC pension liability.
- Pegasus Communications will be presenting a proposal to upgrade the live racing Jumbotron to HD with no increase in the day rate.
- Legal counsel is scheduling a meeting with a key legislator for early January.

Summary: Current law requires the California Gambling Control Commission to establish a 10-member Gaming Policy Advisory Committee for the purpose of discussing matters of controlled gambling regulatory policy and other relevant gambling-related issues. The committee is composed of representatives of controlled gambling licensees and members of the general public in equal numbers. This bill would increase the membership of the committee from 10 to 12 members, and would instead require the committee to be composed of 5 representatives of controlled gambling licensees, 5 members of the general public, and 2 representatives from the Department of Justice.
