CALIFORNIA AUTHORITY OF RACING FAIRS Board of Directors & Live Racing Committee Concurrent Meeting

Tuesday, March 1, 2022

MINUTES

A concurrent meeting of the California Authority of Racing Fairs (CARF) Board of Directors and Live Racing Committee was held at 11:00 A.M., Tuesday, March 1, 2022. The meeting was conducted via teleconference originating at the CARF Office, 1776 Tribute Road, Sacramento, CA 95815.

CARF Board Directors joining by conference call: Stephen Hales, Jerome Hoban, Lauri King, Dana Stoehr and Kelly Violini.

CARF Live Racing Committee members joining by conference call: Jerome Hoban, Lauri King, Rich Silacci.

Staff and Guests participating via conference call: Larry Swartzlander, Heather Haviland, Tom Doutrich, Juliana Gomes, Ann Grottveit, Cody Boyles, Louie Brown, Tiffany Burrow-Loushin, Cindy Olsen and Allen Aldrich.

Agenda Item 1 – Date, Time and Location of Next Meeting: The next CARF Board of Directors and Live Racing Committee meeting is April 5, 2022 via teleconference.

Agenda Item 2 – Public Comment. None.

Agenda Item 3 – Approval of Minutes. Ms. King moved to approve the minutes from the Board of Directors & Live Racing Committee concurrent meeting for October 12, 2021 and February 8, 2022 as presented. Mr. Hales seconded, unanimously approved.

Agenda Item 4 – Report, Discussion and Action, if any on Fantasy Sports. Mr. Swartzlander reported that he has finalized the contract with Pegasus to include a graphics package for Calypso which will be tested in-house on March 15, 2022. On March 31, 2022 Mr. Swartzlander plans to have the Calypso beta test at the Los Angeles County Fairgrounds with all CARF satellite locations having all equipment installed. Mr. Swartzlander plans for the Calypso Challenge to be fully functional by August 1, 2022.

In addition to the beta-test, Mr. Swartzlander has reached out to marketing firms for proposals and plans to present them to the board next meeting.

Agenda Item 5 – Report, Discussion and Action, if any on Legislative Program. Mr. Boyles updated the Board on the three Sports Wagering initiatives: the Pechanga initiative, which excludes CARF, the FanDuel initiative, which has reached viability with 25% threshold, and the other Indian initiative supported by Wilton Rancheria, has till June 30 to reach the 25% signature threshold and get on the November ballot.

The attorney general has recommended that the June 30 submission date be by April 29 to give counties enough time to verify signatures.

Mr. Boyles adds that legislatively, the racing side is quiet but does have spot bills ready if need be. In addition, a recent presentation at the Sacramento Press Club had Senate President Protem Tony Atkins and speaker Anthony Rendon, were both proponents of seeing a legislative compromise for the sports wagering initiatives. Mr. Boyles and Mr. Brown plan to set up meetings between Senate G.O. members and officials from the Alameda County Fair and Big Fresno Fair. Mr. Boyles hopes the outreach to encourage legislators to include the fairs in any talks with reformed sport wagering initiatives.

Agenda Item 6 – Western Fairs Association Update. Ms. King reported that the Western Fairs Associations had their board planning to discuss changes in membership levels and membership fees. Ms. King added that the CARF seat on the WFA Board is valid through 2022 – at the end of this year, the CARF seat will transition to an Associate Member. From the Associate Membership, CARF would then need to be elected from other associate members in order to be on the WFA Board.

This change of the CARF-WFA board seat was due to a change in the WFA Bylaws. Ms. King encourages conversation between Mr. Swartzlander and WFA's Executive Director Sarah Cummings if CARF wishes to preserve the board seat. If the seat were to be preserved, then that would require a change of WFA Bylaws, so Ms. King encouraged quick action from the Board.

Mr. Hoban questioned why WFA had not continued to take "no action" on the CARF seat until further discussions had happened – thus giving CARF another year on the WFA Board. Ms. King explained that it was a two-year seat, so the expiration runs from 2020-2022.

Ms. King added that CARF will have a Board seat on CFA while also an Associate Member, but encouraged conversation to take place between both CARF and WFA.

Agenda Item 7 – Financials. Ms. Gibbons presented the financials and stated that she is still closing a few 2021 items, including Roberts Communication invoices with NCOTWINC and which entity should be responsible. Ms. Gibbons was happy to report that her and Korynn Philpott had been successful in closing all the invoicing concerns.

Ms. Gibbons was happy to report that CARF is underpaid from their purse account last year and she has adjusted the financials to show the numbers in more of an "apples to apples" comparison. Due to COVID and the shift of expenses from fair to fair, Ms. Gibbons noted that there was a drastic swing.

Ms. Gibbons added that all expenses were netted and fairs paid the commissions due.

Mr. Hoban asked Ms. Gibbons what monies, if any, were received from the NCOTWINC PPP loan. Ms. Gibbons reported that NCOTWINC was awarded roughly \$1,000,000, with CARF receiving around \$200,000 – this number was labor-based on mutuel employees used.

Agenda Item 8 – Report, Discussion and Action, if any on Live Racing Operations. Mr. Swartzlander reported that he had spoken with CHRB Vice Chairman Oscar Gonzalez and Executive Director Scott Chaney in regards to stabling for the summer and the status of Calypso. Mr. Swartzlander noted that feedback was positive.

Mr. Swartzlander added that he plans to have a Live Racing Committee meeting in the last week of March to review the proposed stakes and purse schedules and have an option ready for the board to approve in April.

Ms. Haviland noted that the Employee Handbook would be sent out for review on March 7, 2022 and it is up to the Board on whether they would like to create a subcommittee to review it. Mr. Hoban recommended the Finance Committee review the handbook before going to the Board or forming a subcommittee.

Agenda Item 9 – Executive Director's Report. Mr. Swartzlander noted that he is looking forward to a meeting with Thomas Hudnut, the incoming CHRB Commissioner, as well as Commissioners Mitchell and Gonzalez.

In addition, Mr. Swartzlander was asked to support an initiative from UC Davis to fund a new facility to support the creation of a new equine sports medicine facility. Mr. Swartzlander added that UC Davis has only requested that CARF support their initiative and is not asking for any monetary donations.

A concurrent meeting of the California Authority of Racing Fairs (CARF) Board of Directors and Live Racing Committee was held at 11:00 A.M., Tuesday, April 5, 2022. The meeting was conducted via teleconference originating at the CARF Office, 1776 Tribute Road, Sacramento, CA 95815.

Agenda Item 1 – Date, Time and Location of Next Meeting: The next CARF Board of Directors and Live Racing Committee meeting is May 3, 2022 via teleconference.

Agenda Item 2 – Public Comment. None.

Agenda Item 3: Closed Session: Conference with Legal Counsel – Anticipated Litigation. The Board of Directors heard from legal counsel. No action was taken.

Agenda Item 4 – Report, Discussion and Action, if any on Fantasy Sports. Mr. Swartzlander reported that the target date for Calypso Challenge to be implemented at all satellite locations is August 1, 2022.

Mr. Swartzlander added that there had been changes to the timeline due to the resignation of Thoroughbred Owners of California "TOC" CEO Greg Avioli and a possible change in venue from Southern to Northern California. Mr. Swartzlander is hopeful that the beta test will happen in May 2022.

Agenda Item 5 – Report, Discussion and Action, if any on Legislative Program. Mr. Boyles noted that the legislative "spring break" was near and that legislators will return after a week off.

Mr. Boyles added that he and Mr. Hoban had met with Assemblymember Miguel Santiago, the chair of the Senate G.O. Committee, to discuss the possibility of CARF member fairs being written into the proposed sports wagering legislation. Unfortunately, Mr. Santiago echoed Senator Dodd's opinion that any compromise on sports wagering language would most likely not include the fairs.

Both the tribal gaming initiative and the FanDuel initiative have gained enough support that it is most likely California voters will see both on the November ballot. Mr. Boyles adds that while CARF member fairs will not see any inclusion in the November initiatives, cafe style sports betting in satellites may be the best route to pursue at this time.

Agenda Item 6 – Western Fairs Association Update. Ms. King reported that the Western Fairs Association had their board planning meeting and plans to update their bylaws and restructure the board seats. Ms. King added that once the revisions are made, they will be made available to the membership within 30 days.

Agenda Item 7 – Financials. Ms. Gibbons presented the preliminary financials from February 2022. No questions.

Agenda Item 8 – Report, Discussion and Action, if any on Live Racing Operations. Mr. Swartzlander reported that he has submitted the license for the Alameda County Fair for CHRB's review and has notified the following fairs that he will be contacting them to address their licenses. The Alameda County Fair license will be heard on May 19, 2022.

Mr. Swartzlander added for that he and Mr. Doutrich have reached an agreement on what is required to accommodate both horses and horsemen for stabling during Golden Gate Field's closure. Mr. Swartzlander noted that he will be touring the Alameda County Fair barn areas with California Thoroughbred Trainer's Alan Balch and Thoroughbred Owners of California Lindsay LaRoche to discuss any concerns either party may have.

Mr. Swartzlander included that he has reached out to the Sonoma County Fair to coordinate auxiliary stabling for their August meet. At this time Mr. Swartzlander has not had any replies from Ms. Bartling.

Agenda Item 9 – Executive Director's Report. Mr. Swartzlander reported that he had a successful hip replacement surgery and looks forward to travelling for the next set of meetings.

Summary: The Horse Racing Law requires each licensed racing association to designate a certain number of racing days to be conducted as charity days for the purpose of distribution of the net proceeds to beneficiaries. Current law requires that beneficiaries of these proceeds be a nonprofit corporation or organization entitled by law to receive a distribution made by a distributing agent, exempt or entitled to exemption from state and federal income taxes, engaged in specified beneficial activities, and approved by the California Horse Racing Board. Current law requires, among other distributions, that at least 30% of the distribution from charity day racing go to charities associated with the horse racing industry. This bill would instead require that at least 40% of the distribution from charity day racing go to charities associated with the horse racing industry.

Summary: Current law establishes the Bureau of Gambling Control under the direction of the Department of Justice. Current law requires the commission to establish a 10-member Gaming Policy Advisory Committee composed of representatives of controlled gambling licensees and members of the general public in equal numbers. Existing law requires the executive director of the commission to convene the committee, from time to time, for the purpose of discussing matters of controlled gambling regulatory policy and any other relevant gambling-related issue. This bill would increase the membership of the committee from 10 to 12 members and would require the additional members to include one representative of academia who possesses knowledge on matters related to gaming and one representative from the bureau. The bill would require the executive director to convene the committee at least twice every calendar year, rather than from time to time.

Summary: The Horse Racing Law authorizes the California Horse Racing Board to issue to any person who makes an application in writing, complies with specified provisions of this law, and who makes the deposit to secure payment of the license fee, a license to conduct a horse racing meeting at the track specified in the application, provided that the board determines that the issuance of the license will be in the public interest and will subserve the purposes of the Horse Racing Law. The Horse Racing Law makes it a misdemeanor for a person to directly or indirectly hold or conduct a meeting where there is horse racing and betting on the results, as specified, without first having procured a license. This bill would instead make it a felony for a person to knowingly hold or conduct any meeting or activity where there is horse racing and betting on the results, as specified, without first having procured a license.

Summary: Current law requires, for every year that the Breeders' Cup World Championship series is conducted at a race meeting in California, that specified amounts that would have otherwise been distributed to a purse account be made available to the organization operating the series for the purpose of promoting and supporting the Breeders' Cup World Championship. This bill would instead require these amounts to be available to the thoroughbred racing association hosting the Breeders' Cup World Championship as well as to the organization operating the series. This bill contains other related provisions and other existing laws.

Summary: Current law authorizes the California Horse Racing Board to approve minisatellite wagering sites, as defined, under specified conditions. Current law requires an organization formed by associations or fairs to operate the audiovisual signal system to execute a specified agreement with the association conducting a racing meeting and the minisatellite wagering facility that specifies, among other things, the components of its racing program, including live, out-of-zone, out-of-state, and out-of-country races, that an association or fair will make available to the site. This bill would explicitly require the agreement to specify which live in-state races would be provided by the association or fair to the site. The bill would also make nonsubstantive changes, including deleting obsolete language.

Summary: The Gambling Control Act establishes the California Gambling Control Commission, which is responsible for licensing and regulating various gambling activities and establishments. Current law requires the commission to establish a 10-member Gaming Policy Advisory Committee and requires the executive director of the commission to convene the committee, from time to time, for the purpose of discussing matters of controlled gambling regulatory policy and any other relevant gambling-related issue. This bill would require the executive director to convene the committee at least once annually, rather than from time to time, for the purpose of discussing those gambling policy matters and any other gambling-related issue.

Summary: Current law prohibits an ordinance that would result in an expansion of gambling in the city, county, or city and county from being valid unless the amendment is approved by a majority of the voters. Current law requires an amendment to a city or county ordinance relating to a gambling establishment or the act to be submitted to the Department of Justice for review and comment before the ordinance is adopted by the city or county. This bill would create an additional exception to that prohibition by authorizing a city, county, or city and county, commencing January 1, 2022, to amend its ordinance to increase the number of gambling tables that may be operated in a gambling establishment by up to 2 tables each calendar year, up to a maximum total of 10 additional tables, above the number of tables authorized in the ordinance in effect on January 1, 2022. The bill would

authorize a city, county, or city and county's jurisdictional limit to be expanded to accommodate the increase of gaming tables authorized by the bill. The bill would extend until January 1, 2028, the prohibition against a city, county, or city and county amending an ordinance to expand gaming in that jurisdiction beyond that permitted on January 1, 1996.
