# Board of Directors & Live Racing Committee Concurrent Meeting Tuesday, April 4, 2023

#### **MINUTES**

A concurrent meeting of the California Authority of Racing Fairs (CARF) Board of Directors and Live Racing Committee was held at 11:00 A.M., Tuesday, April 4, 2023. The meeting was held via teleconference originating at the CARF office, 1776 Tribute Road, Sacramento, CA 95815.

CARF Board Directors joining by conference call: Stephen Hales, Dan Jacobs, Lauri King, Tom Martinez, Dana Stoehr and Kelly Violini.

CARF Live Racing Committee members joining by conference call: Lauri King and Tom Martinez.

Staff and Guests participating via conference call: Larry Swartzlander, Tom Doutrich, Heather Haviland, Juliana Gomes, Raechelle Gibbons, Ann Grottveit, Cody Boyles, Matt Cranford, Bill Nader, Angel Moore, Jeanne Wasserman, Greg Gomes, Tag Wotherspoon and Stacey Lapham.

**Agenda Item 1 – Date, Time and Location of Next Meeting:** The next CARF Board of Directors and Live Racing Committee meetings will be held Tuesday, May 2, 2023 via teleconference.

Agenda Item 2 - Public Comment. None.

Agenda Item 3 – Closed Session: Conference with Legal Counsel – Anticipated Litigation. Item deferred.

Agenda Item 4 – Approval of Live Racing Committee Meeting Minutes from February 28, 2023. {ACTION} Ms. King moved to approve the February 28, 2023 CARF Live Racing Committee meeting minutes as presented. Mr. Hales seconded, unanimously approved.

Agenda Item 5 – Approval of Board of Director's Meeting Minutes from March 14, 2023. {ACTION} Ms. King moved to approve the March 14, 2023 CARF Board of Directors & Live Racing Committee concurrent meeting minutes as presented. Mr. Hales seconded, unanimously approved.

**Agenda Item 6 – Report, Discussion and Action, if any, on Legislative Program.** Mr. Boyles reported that the members of the legislature are on spring break this week and back in their home districts for constituent services and local meetings, but will reconvene April 10.

April 28 is the deadline for policy committees to hear and report on fiscal bills introduced in their house of origin. The last day for non-fiscal bills to be heard in committee is May 5. The CARF-sponsored spot bill, AB 1074 (Alanis) was referred to the Committee on Governmental Organization and will be heard April 26. The bill will subsequently be amended prior to being reviewed by the Senate Appropriations Committee and any language changes will be shared at the next meeting.

Agenda Item 7 – Report, Discussion and Action, if any, on Fantasy Sports. Mr. Swartzlander reported that the CARF Finance Committee met to review the BetMakers' Global Tote agreement. That document is currently undergoing minor changes and will be brought back to the Finance Committee for final approval and recommendation to the full Board.

Mr. Swartzlander reported that one major change to the tote agreement is that no hardware will be installed initially at the satellites and all contest entries will be made via the Internet. Mr. Swartzlander feels this change is a net positive and will help facilitate the Beta test in June and full rollout August 1.

**Agenda Item 8 – Financials.** Ms. Gibbons presented the financials provided in the meeting packet. Mr. Martinez called for questions; no questions at this time.

Ms. Gibbons reported that the field work for CARF's 2022 audit is scheduled for May 1-5, 2023.

**Agenda Item 9 – Report, Discussion and Action, if any on Live Racing Operations.** Mr. Swartzlander reported on three areas specific to live racing operations:

<u>CHRB License Applications:</u> Mr. Swartzlander welcomed Bill Nader, President & CEO of the Thoroughbred Owners of California (TOC). Mr. Swartzlander reported that CARF's purse structure, stakes schedule and incentives are being reviewed by the TOC and a meeting of TOC staff and representatives will be convened next week to discuss the package.

Mr. Swartzlander stated that the Pleasanton California Horse Racing Board (CHRB) license to conduct racing will be heard May 18 in Sacramento and the Cal Expo license will be heard June 15 in Pleasanton.

<u>Horse Recruitment:</u> Mr. Doutrich stated that he had a successful recruitment trip at Turf Paradise in Arizona. The decision of Arizona Downs management to not race this summer has created an opportunity for 6-7 trainers with 70-100 horses to join the CARF circuit. Stall applications are due April 15.

Other: Mr. Swartzlander reported that Golden Gate Fields (GGF) has officially announced that they will close the stabling area this summer through the first week of Santa Rosa, necessitating a stabling agreement between CARF and Santa Rosa.

Bill Nader greeted the group and added that TOC has reached out to GGF to explore the possibility of them opening for stabling earlier, if possible, to accommodate the Santa Rosa meet.

**Summary:** Current law provides comprehensive regulation of ticket sellers and makes violations of those provisions a misdemeanor. Current law imposes various refund requirements on a ticket seller, including a requirement to issue a refund upon request to a ticket purchaser for canceled, postponed, or rescheduled events. Current law also imposes various disclosure requirements on a ticket seller, including a requirement to disclose to a purchaser the location of the seat represented by the ticket, as specified. This bill would revise and recast those provisions by expanding the definition of a ticket seller to include a primary contractor or platform, as defined, and would instead apply the refund requirement relating to the postponement or rescheduling of an event only to primary contractors. The bill would impose various disclosure requirements on ticket sellers relating to ticket price, including that the ticket seller would be required to display the total cost and fees for a ticket prior to the ticket being selected for purchase.

**Summary:** Current law requires the California Gambling Control Commission to establish a 10-member Gaming Policy Advisory Committee composed of representatives of controlled gambling licensees and members of the general public in equal numbers. Current law requires the executive director of the commission to convene the committee, from time to time, for the purpose of discussing matters of controlled gambling regulatory policy and any other relevant gambling-related issue. This bill would increase the membership of the committee from 10 to 12 members and would require the additional members to include one representative of academia who possesses knowledge on matters related to gaming and one representative from the bureau. The bill would require the executive director to convene the committee at least twice every calendar year, rather than from time to time.

**Summary:** Would, except as specified, prohibit a person from installing an application for a social media platform on a state-owned or state-issued electronic device if specified conditions are met, including that the social media company that owns the application is domiciled in, has its principal place of business in, has its headquarters in, or is organized under the laws of, a country of concern. The bill would also prohibit a person from installing an application for a social media platform owned or controlled by specified companies from being installed on a state-owned or state-issued electronic device. The bill would define various terms for these purposes.

**Summary:** Current law requires an amendment to a city or county ordinance relating to a gambling establishment or the Gambling Control Act to be submitted to the Department of Justice for review and comment before the ordinance is adopted by the city or county. Prior law, until January 1, 2023, prohibited the commission from issuing a gambling license for a gambling establishment that was not licensed to operate on December 31, 1999, except as specified. This bill would reenact that prohibition until January 1, 2043, and would prohibit the commission from issuing a gambling license for a gambling establishment that was not licensed to operate on December 31, 2022, and that is pending before the commission as of January 1, 2024. The bill would also invalidate a gambling license for a gambling establishment that was not licensed to operate on December 31, 2022, and that was issued between December 31, 2022, and January 1, 2024.

**Summary:** Current law authorizes the formation of nonprofit corporations under the Nonprofit Public Benefit Corporation Law by 20 or more persons for the prevention of cruelty to animals. Current law authorizes a corporation, or human officer thereof, to proffer a complaint against any person, before any court or magistrate having jurisdiction, for the violation of any law relating to or affecting animals and to aid in the prosecution of the offender before a court or magistrate. This bill would authorize a corporation, or humane officer thereof, proffering a complaint under existing law to bring it as a civil action to obtain specific or injunctive relief to enforce laws relating to or affecting animals.

**Summary:** Current law requires that, whenever a fair conducts a program of horse races on which there is parimutuel wagering, the fair, so far as practicable, provide a program of racing that includes thoroughbred racing, quarter horse racing, Arabian racing, and Appaloosa racing, if a sufficient number of horses is available to provide competition in one or more races. Under current law, parimutuel wagering may be conducted on barrel races, show jumping races, and steeplechase races at any public or private facility that has been approved and licensed by the board. This bill would require that, whenever a fair conducts a program of horse races on which there is parimutuel wagering, the fair, so far as practicable, provide a program of racing that includes, in addition to the types of racing included under existing law, steeplechase racing, barrel racing, and show jumping racing.

**Summary:** Current law authorizes the California Horse Racing Board to approve minisatellite wagering sites, as defined, under specified conditions. Current law requires an organization formed by associations or fairs to operate the audiovisual signal system to execute a specified agreement with the association conducting a racing meeting and the minisatellite wagering facility that specifies, among other things, the components of its racing program, including live, out-of-zone, out-of-state, and out-of-country races, that an association or fair will make available to the site. This bill would explicitly require the agreement to specify which live in-state races would be provided by the association or fair to the site.

**Summary:** Current law requires a person who deals, operates, carries on, conducts, maintains, or exposes for play any controlled game in this state, or who receives any compensation or reward, or any percentage or share of the money or property played, for keeping, running, or carrying on any controlled game in this state, to apply for and obtain a valid state gambling license, key employee license, or work permit. Current law provides that an owner of a gambling enterprise is known as the owner-licensee. Under existing law, other persons who also obtain a state gambling license do not receive a separate license certificate, but instead the license of those persons are endorsed on the license certificate that is issued to the owner-licensee. Under current law, a key employee license entitles the holder to work as a key employee in any key employee position at any gambling establishment, provided that the key employee terminates employment with one gambling establishment before commencing work for another. Current law also authorizes a key employee with a valid personal portable license to work as a key employee in any key employee position in more than

one gambling establishment and requires the commission to establish a program for portable personal licenses for key employees. This bill would repeal those provisions relating to key employees working at different gambling establishments, would authorize the commission to adopt regulations to waive the requirement that an application be accompanied by a deposit and that an investigation be performed by the department, as specified, and would require the commission to adopt regulations implementing a new owner license that allows for a person or entity to be endorsed on the license certificate of multiple gambling enterprises.

**Summary:** The Horse Racing Law makes it a misdemeanor for a person to directly or indirectly hold or conduct a meeting where there is horse racing and betting on the results, as specified, without first having procured a license. This bill would make it a misdemeanor and subject to a civil fine of up to \$25,000 per day, per violation, for a person to directly or indirectly hold, conduct, or facilitate any horse racing in which horses compete against each other without first having procured a license. By creating a crime, this bill would impose a state-mandated local program. This bill contains other related provisions and other existing laws.

**Summary:** The Horse Racing Law authorizes a thoroughbred racing association or fair to distribute the audiovisual signal and accept wagers on the results of out-of-state thoroughbred races conducted in the United States during the calendar period the association or fair is conducting a race meeting, including days on which there is no live racing being conducted by the association or fair, without the consent of the organization that represents horsemen and horsewomen participating in the race meeting and without regard to the amount of purses. Under that law, the total number of thoroughbred races imported by associations or fairs on a statewide basis under these provisions are required to not exceed 50 per day on days when live thoroughbred or fair racing is being conducted in the state, with the exception of prescribed races. This bill would exempt from the 50 imported race per day limitation, races imported that are part of the race card of the New York Stakes.

**Summary:** Current law requires the Department of Technology to identify, assess, and prioritize highrisk, critical information technology services and systems across state government, as determined by the department, for modernization, stabilization, or remediation. Current law requires the Office of Emergency Services to establish and lead the California Cybersecurity Integration Center (CCIC). Existing law states that the CCIC's mission is to reduce the likelihood and severity of cyber incidents that could damage California's economy, its critical infrastructure, or public and private sector computer networks in the state. Current law requires the CCIC to serve as the central organizing hub of state government's cybersecurity activities and coordinate information sharing with specified entities, including local, state, and federal agencies. This bill would require state entities to prohibit applications for social media platforms from being downloaded or installed on those entities' state-owned or state-issued devices if specified conditions are met, including that an entity of concern or a country of concern directly or indirectly owns, directly or indirectly controls, or holds 10% or more of the voting shares of the social media company that owns the application. The bill would define various terms for these purposes.

**Summary:** Current law, until January 1, 2024, authorizes the legislative body of a local agency to use alternate teleconferencing provisions during a proclaimed state of emergency or in other situations related to public health that exempt a legislative body from the general requirements (emergency provisions) and impose different requirements for notice, agenda, and public participation, as prescribed. The emergency provisions specify that they do not require a legislative body to provide a physical location from which the public may attend or comment. Current law, until January 1, 2026, authorizes the legislative body of a local agency to use alternative teleconferencing in certain circumstances related to the particular member if at least a quorum of its members participate from a

singular physical location that is open to the public and situated within the agency's jurisdiction and other requirements are met, including restrictions on remote participation by a member of the legislative body. This bill would authorize a legislative body to use alternate teleconferencing provisions similar to the emergency provisions indefinitely and without regard to a state of emergency. The bill would alternatively define "legislative body" for this purpose to mean a board, commission, or advisory body of a local agency, the membership of which board, commission, or advisory body is appointed and which board, commission, or advisory body is otherwise subject to the Ralph M. Summary: Current law requires a tax return filed with the California Department of Tax and Fee Administration (CDTFA) that reports gross receipts for sales and use tax purposes to segregate the gross receipts of the seller and the sales price of the property on a line or a separate form when the place of sale in this state or for use in this state is on or within the real property of a state-designated fair, as defined, or any real property of a state-designated fair that is leased to another party. Existing law requires, on or before November 1 of each year, the CDTFA to report to the Department of Finance the amount of the total gross receipts segregated on these tax returns for the prior fiscal year, and that 3/4 of 1% of the total gross receipts be included in the next annual Governor's Budget for use by the Department of Food and Agriculture for allocation to fairs and that those funds be transferred by the Controller to the Fair and Exposition Fund, which is continuously appropriated, as prescribed. Before any allocation is made to fairs from those funds, existing law requires the CDTFA to be paid the actual cost from those funds for administering these provisions. This bill would also require, before any allocation to fairs is made from these funds, the Department of Food and Agriculture to be paid the cost of administering the allocation of these funds to fairs, as determined by the Secretary of Food and Agriculture, in an amount not to exceed 5% of the funds. By expanding the use of continuously appropriated funds, the bill would make an appropriation.
